

GENERAL PERMISSION TO PUBLISH AND ONLINE SERVICES 2018

Dear Parent/ Caregiver,

I am seeking your permission to publish information about your child for the purposes of sharing his/her experiences with other students, informing the school and broader community about school and student activities and recording student participation in noteworthy projects or community service.

This information may include your child's name, age, class and information collected at school such as photographs, sound and visual recordings of your child, your child's work and expressions of opinion such as in interactive media.

The communications in which your child's information may be published include but are not limited to:

- Public websites of the Department of Education including the school website, the Department of Education intranet (staff only), blogs and wikis.
- Department of Education publications including the school newsletter, annual school magazine and school report, promotional material published in print and electronically including on the Department's websites.
- Official Department and school social media accounts on networks such as YouTube, Facebook and Twitter.

Parents should be aware that when information is published on public websites and social media channels, it can be discoverable online for a number of years, if not permanently. Search engines may also cache or retain copies of published information. Published information can also be linked to by third parties.

ONLINE SERVICES 2018

The Department of Education provides students with access to the internet, a customised Gmail account and online applications such as Google Apps. These resources enable students to collaborate with peers, publish online and create personalised research portals.

When accessing some online services your child's data, including but not limited to, your child's name and works may be shared with and stored in a location outside of the Department of Education environment.

For parent/carers who decline consent for their child to access DoE Online Services, they will need to understand the implications for their child. The student will not be provided with a Department of Education (DoE) account. The student would then **NOT** be able to log in to the DoE network or access:

- DoE student portal
- DoE student email (facilitated via Google Apps)
- Connection to any Bring your Own Device (BYOD) to the DoE network
- Other Google Apps provided by DoE
- Log in to or participate in the Premier's Reading Challenge via the website.
